## **Ocean County Irish Festival**

his is going to be the single most important Irish Festival we host in 2022. With the emergence of our new club space, anticipated growth with club membership and overall optics of what we do as a Non-Profit 501c3 organization, we will approach the Festival differently this year. Our investment into the Advertising structure (easily the most profitable part of the festival) is vital. Here are some of the upgrades you can expect which will help each and every member become part of the sales team:

- 1) We are designing a Website dedicated to the Festival only. Our current member & general website will continue to function independently, however Linked to the new Domain. Same for FB/Insta or any other platforms needed. The Festival Website will have Festival info and Vendor and Promotional Partner Registration & Payment acceptance. It will also include previous Festival highlights, Club information, and other pertinent details. It will also have a new domain name: www.OceanCountyIrish-Festival.com. (We are confirming it is available.)
- 2) We are also creating a Media Kit to help members sell the advertising. This Kit will include everything you need to know about the Festival, and can be accessed via a link to forward to potential promotional partners (formally Sponsors) or print version. Included will be demographics of Ocean County, the Plans and Costs offered, previous highlights of our last 5 festivals, and so much more. No excuses with this tool provided why we cannot bring on new advertising and increase our profitability.
- 3) Festival Business cards will be provided to ALL members. This identifies you as a standing member of the Club and validates you as part of the sales team!
- 4) We have incorporated several different Advertising plans to show potential Promotional Partners which will all be in the Media Kit. We will sell Ad Plan PP's (i.e., Galway Gold, Dublin Silver & Belfast Bronze), Event PP's (i.e., Stage, Kiosk,

Mug, Funland Kidz Korner, Royal Basket of Cheer), and lastly, our Friends & Family Connect Plan where they will have access to 25 words or less for personalized shoutouts on the Ad Van scrolled throughout the event. Just like any business, our costs for goods have risen. With that said, ALL plan costs will go up as well.

5) We have also adopted a Value Proposition/ Tagline for the Festival and anything we do moving forward with Fundraising. This Value proposition is simple and concise but best describes our club in short:



- 6) Last year, we had great participation in getting Sponsors (now considered Promotional Partners). I was extremely proud of what WE accomplished. This year we need more. We have more! We will once again be Team based for accomplishing our goals, and this will be discussed at our next General Membership meeting. - 8) Lastly, we need to Identify our Benefactors before the Festival and have some of them present if attainable. These Benefactors need to be promoted early & often. Remember,



#### **Proposed Amendment 1**

#### **Current By-Law**

#### **Article VI: Membership Dues**

The annual dues of this Organization for active members shall be \$100.00 payable by April 1. Dues not paid by this date shall be subject to a late fee in the amount of \$10.00 per month for each month that they are not paid.

Active members 65 years of age or older with 10 years continuous membership in the club, and former Presidents, will be considered Senior Members. The annual dues of this Organization for Senior Members shall be \$25.00 payable by Election Day.

Disabled members will be considered for dues-free membership by the Executive Board.

#### **Proposed Amendment**

#### **Article VI: Membership Dues**

The annual dues of this Organization for active members shall be \$100.00 payable by January 1st. Dues not paid by this date shall be subject to a late fee in the amount of \$10.00 per month for each month that they are not paid. If a member has not paid his annual dues by April 1st, that member shall be notified by the Corresponding Secretary, by regular mail or e-mail, that his membership is suspended, pending termination, unless all dues, including late fees, are paid by May 1st. If that member fails to pay his annual dues by that date, then his membership will be considered to have been terminated. That members termination will then be processed pursuant to Article X: Termination of Membership.

Annual dues for new members shall be prorated according to the date that the new member has been accepted into the Club. Members accepted in the first quarter of the year (January, February or March) will be assessed 100% of the annual dues (\$100.00). Members accepted in the second quarter of the year (April, May or June) will be assessed 75% of the annual dues (\$75.00). Members accepted in the third quarter of the year (July, August or September) will be assessed 50% of the annual dues (\$50.00). And members accepted in the fourth quarter of the year (October, November or December) will be assessed 25% of the annual dues (\$25.00).

Disabled members will be considered for dues-free membership by the Executive Board.

#### **Proposed Amendment 2**

#### **Current By-Law**

#### **Article VII: Application for Membership**

Any male, 21 years of age or older and with at least one-eighth Irish Ancestry or a descendant of a member in good standing, shall be eligible for membership.

Any individual eligible for membership may apply for membership through any member in good standing who has been a member for one year (the sponsor). Such application for membership shall be submitted to the Chairman of the Membership Committee along with a non-refundable application fee in an amount to be determined by the Executive Board.

Upon receipt of an application and \$25.00 fee, the Membership Committee will conduct a check of the individual's background and character, as well as their qualifications for membership, during an initial screening.

Upon review and acceptance by the Membership Committee, an individual will become a candidate for membership in the club when:

- 1. The Membership Committee reads the name of the individual requesting membership at the first general membership meeting following his screening: and
- 2. The sponsor of the individual requesting membership addresses the general membership regarding the individual's background and character, and reasons for sponsoring the individual for membership.

The candidate will then begin a 1-month trial period during which the candidate must demonstrate his willingness to participate in the various works and social functions of the Organization.

At the second general membership meeting following the candidate's name being read, the Chairman of the Membership Committee shall again read the candidate's name, at which time a unanimous acceptance by the general membership will be required.

At the completion of the trial period and the unanimous acceptance by the general membership, the candidate will pay his annual dues in an amount to be determined by the Executive Board and prorated for the year.

#### **Denial by Membership Committee**

The Membership Committee shall be required to submit to the Executive Board the names of any applicant not approved for presentation to the general membership and the reasons for non-approval. The Executive Board may by a majority vote of those present overrule the disapproval of the Membership Committee and order that such names be presented to the general membership for consideration at the next meeting.

#### **Reduced Application Fee Incentive Periods**

In an effort to promote the Club and to increase membership applications, the Organization will institute periodic membership application incentives. During the months of March and September, membership application fees will be reduced to one dollar (\$1.00). Any applications received during either of these two months will be eligible for this reduced application fee. The annual dues of \$100.00 will remain unaffected by this incentive.

At the second general membership meeting following the candidate's name being read, the Chairman of the Membership Committee shall again read the candidate's name, at which time a unanimous acceptance by the general membership will be required.

At the completion of the trial period and the unanimous acceptance by the general membership, the candidate will pay his annual dues in an amount to be determined by the Executive Board and prorated for the year *as provided in Article VI: Membership Dues*.

#### **Denial by Membership Committee**

The Membership Committee shall be required to submit to the Executive Board the names of any applicant not approved for presentation to the general membership and the reasons for non-approval. The Executive Board may by a majority vote of those present overrule the disapproval of the Membership Committee and order that such names be presented to the general membership for consideration at the next meeting.

#### **Reduced Application Fee Incentive Periods**

In an effort to promote the Club and to increase membership applications, the Organization will institute periodic membership application incentives. During the months of March and September, membership application fees will be reduced to one dollar (\$1.00). Any applications received during either of these two months will be eligible for this reduced application fee. The annual dues of \$100.00 will remain unaffected by this incentive.

#### **Proposed Amendment 3**

#### **Current By-Law**

#### **Article X: Termination of Membership**

Any member who has not settled their annual dues obligation by October 1<sup>st</sup> shall be considered to have terminated his membership from the Club. A member's termination shall be effective upon written notification by the Executive Board by regular mail or e-mail to the member's last known address

A member may also have his membership terminated under Article XII: Censure.

#### **Proposed Amendment**

#### **Article X: Termination of Membership**

Any member who has not settled their annual dues obligation by *May 1st*, and who has been duly notified that his membership has been suspended pending termination, pursuant to Article VI: Membership Dues, shall be considered to have terminated his membership from the Club. A member's termination shall be effective upon written notification by the Corresponding Secretary by regular mail or e-mail to the member's last known address.

A member may also have his membership terminated under Article XII: Censure.
